## CITY OF LONG GROVE COUNCIL MEETING MINUTES September 13, 2011

Mayor Weibel called the Long Grove City Council Meeting to order at 7:00 PM at City Hall.

Roll Call: Present: Davis, Schmidt, Thiessen, Barreca and Abington

Absent: None

The agenda was approved as presented on a motion by Abington and seconded by Davis, all ayes, motion carries.

A motion was made to delete the Police Report from the Consent Agenda by Schmidt and seconded by Barreca, all ayes, motion carries.

A motion was made to approve the Consent Agenda (9/13/11 Claims, August 9 and 23, 2011 Council minutes, Public works report, and Miltenberger P&Z resignation) on a motion by Thiessen and second from Abington, all ayes, motion carries.

Mayor Weibel welcomed guests to the meeting.

**New Business-**Tom Sunderbruch, Chair of the Scott County Board of Supervisors spoke to the Council and welcomed any questions. Larry Minard, Board Member spoke of the 175<sup>th</sup> Anniversary of Scott County and several different programs the County is providing commemorating 175 years. Other Board members present were: Jim Hancock, Carol Eberhart and Bill Cusack. Also attending was Scott County Administrator, Dee Bruemmer. Long Grove Council Member, Brian Schmidt thanked all members for their contribution to the Eldridge-Long Grove Recreational Trial.

Scott Daniels read a letter signed by him and his wife regarding the annexation and rezoning of property across the road from their property. He also presented the Council with a petition signed by neighboring property owners opposing any attempt to rezone the property.

Trick or Treat Night was set for Sunday, October 30, 2011 from 6:00pm to 8:00pm on a motion by Thiessen and second by Barreca, all ayes, motion carries.

The 2011 Street Finance Report was approved on a motion by Thiessen and second by Schmidt, passing Resolution 2011-11, all ayes, motion carries.

The Maintenance Agreement Draft for the Eldridge-Long Grove Recreational Trail was approved on a motion by Schmidt and second by Abington, all ayes, motion carries.

Public Works Director, Joel McCubbin presented a quote from Municipal Street Improvements for annual street maintenance and a listing of the streets. The quote of \$12,962.60 was approved on a motion by Abington and second by Davis, all ayes, motion carries.

**Old Business-**Two bids were received for the Lagoon Sludge Removal and Disposal, Marten Trucking at \$135,750.00 and Nutri-Ject Systems, Inc. at \$114,129.28. On the recommendation of the City Engineer, Resolution 2011-12, Sludge Removal and Disposal bid was approved to award the contract to Nutri-Ject on a motion by Schmidt and second by Abington, roll call vote, all ayes, nays-none, motion carries.

The sidewalk project was referred to a Committee of the Whole meeting set for 6pm on October 3, 2011.

City Clerk, Jackie Wilcox reported that information had been received concerning the Scott County Waste Commission grant. The Commission purchased a 100% recycled bench that has been place on the north side of City Hall. Residents of Long Grove will be able to receive E-waste disposal for the remainder of this fiscal year. A postcard will be mailed to residents. The Fall Clean Up on October 13, 2011 will be included in the grant.

Public Comment: Keith Riewerts presented Council with a letter concerning drainage on his property. No action taken, not an agenda item.

Jill Grunwald asked about park maintenance, soccer fields, Ordinance for pools and bicyclist on the road after the trail is complete. No action taken, not an agenda item.

Abington made a motion to adjourn the meeting at 8:05pm, with a second by Davis, all ayes motion carries.
