A RESOLUTION AUTHORIZING EMPLOYEE WAGES FOR THE BUDGET FY21

WHEREAS THE CITY COUNCIL OF THE CITY OF LONG GROVE, IOWA, has reviewed the current personnel and payroll structure of the City of Long Grove,

WHEREAS THE CITY COUNCIL OF THE CITY OF LONG GROVE, IOWA, has reviewed the FY21 budget, federal cost of living adjustments, and any recommendation from annual performance evaluations,

WHEREAS THE CITY COUNCIL OF THE CITY OF LONG GROVE, IOWA, has revised the attached wage scale to include recommendation of minimum and max salary amounts for each job classification, has reduced the step scale percentage increase from 4.5 % to 2.5 % , and has decreased the total number of steps in the wage scale document.

WHEREAS THE CITY COUNCIL OF THE CITY OF LONG GROVE, IOWA, proposes that cost of living adjustments be provided to each employee in the years that they are not scheduled to receive a step increase.

WHEREAS THE CITY COUNCIL OF THE CITY OF LONG GROVE, IOWA AUTHORIZES the following positions and persons shall be paid the salaries or wages indicated, less legally required or authorized deductions from the amounts set out below, on the last business day prior to the 16<sup>th</sup> and last business day of each month, and to make such contributions to IPERS and social security or other purposes as required by law or authorization of the Council, all subject to audit and review by the Council:

- Pam Petersen, Deputy Clerk, LG 5 PT, Step 5, \$16.61 per hour
- Giles Looney, LG 4, Plan and Zone/Electric As Needed, \$30.00 per hour
- Mark Abdon, Seasonal, \$18.00 per hour
- Marvin Henningsen, Seasonal, \$18.00 per hour
- Kent Pennel, Seasonal, \$18.00 per hour

WHEREAS THE CITY COUNCIL OF THE CITY OF LONG GROVE, IOWA AUTHORIZES the wages indicated above to be effective July 1<sup>st</sup> 2020.
