

## **RESOLUTION 2019-18**

### **A RESOLUTION APPROVING A 28E AGREEMENT BETWEEN SCOTT COUNTY AND THE CITY OF LONG GROVE AUTHROZING THE LONG GROVE CODE OF ORDINANCES, CHAPTER 150 TO BE ADMINISTERED BY THE SCOTT COUNTY PLANNING AND DEVELOPMENT DEPARTMENT.**

**WHEREAS**, the City of Long Grove, Scott County, State of Iowa, considers it to be of the best interests for residents of Long Grove if the Long Grove Code of Ordinances, Chapter 150 – Building Code is administered by the Scott County Planning and Development Department, a department of the Scott County Board of Supervisors.

**WHEREAS**, the City Council of Long Grove, Iowa hereby delegates the following duties and responsibilities of the above mentioned regulations to the Scott County Department of Planning and Development:

- To receive and process building permit applications at the office of Scott County Planning and Development;
- To inspect construction and work authorized by said permits and as required by Long Grove City Ordinances in a timely and professional manner;
- To collect and retain all fees received as required by Long Grove City Ordinances;
- To provide personnel at the office of Scott County Planning and Development to answer questions regarding building codes and building permits;
- To maintain records of building permits at the office of Scott County Planning and Development;
- To notify permit holders of violations and all required corrective actions;
- To summarize all building permits issued in the City of Long Grove and provide a report for the City Council from time to time as requested; and
- To accomplish any other duties normally associated with administering building codes which is not inconsistent with other provisions of this Agreement or local, State or Federal law.


**WHEREAS**, in consideration for the work performed under this agreement the Scott County Department of Planning and Development shall retain all building permit fees collected.


**WHEREAS**, the Resolution will take effect immediately following the passing of the proposed Ordinance Amendment 01-2019, amending the City of Long Grove “BUILDING AND PROPERTY REGULATIONS” CHAPTER 150 BUILDING CODE to adhere to the Scott County building code for enforcement purposes.

**NOW THEREFORE BE IT RESOLVED**, that the City Council of the City of Long Grove Iowa, hereby approves the attached 28E agreement between the City of Long Grove, Scott County, State of Iowa and the Scott County Planning and Development Department, a department of the Scott County Board of Supervisors and authorizes the Mayor to execute said agreement, pending the passing of the proposed Ordinance Amendment 01-2019.
